2. Board Feedback

Deb Cryderman, Director of CPL from 2011-2018, recently won the Queen's Jubilee Medal for Public Service. Many of Deb's initiatives at CPL were cited. Excerpt from an email from the Public Library Service Branch:

"Deb Cryderman has been a leader in making Alberta's libraries more inclusive and into welcoming spaces for vulnerable patrons and marginalized communities. She has led programs such as "Snacks in the Stacks" that address food insecurity for school-aged kids, has created safe spaces for LGBQT teenagers, initiated Period Poverty action plans, and hosted Death Cafes for people to learn about palliative care and bereavement strategies. During the pandemic closures, Deb and the Grande Prairie Library became one of the first libraries to offer a curbside delivery service so people could still borrow materials: Grande Prairie shared their model and lessons learned freely with other communities so libraries across Alberta could adapt and copy the service. Deb has worked at a variety of libraries across the Province: she has been Director at Stettler Public Library, at Camrose Public Library, and is currently leading the Grande Prairie Public Library. Deb also volunteers as an active member of the Alberta Public Library Administrator's Council (APLAC), was president of the Library Association of Alberta from 2016 to 2019, and was chair of Alberta Library Conference Planning committee from 2018-2021."

e. Alyssa Martin (current CPL Director) will be going on parental leave in 2023, and the Interim Director job will need to be posted in January of 2023. A Personnel Committee will need to be selected as current members will be done their terms at this point.
