  - Governance

  - Finance:
    - Y/E financial documents need to be prepared to send to the auditor.
    - Charitable Status
      - May benefit the board & to wait until after viability decision is made. Will continue to keep application status current during this process.
      - Should designate a key person of contact from the finance committee to maintain a relationship with Artist in Residency people.
- Banking Access
