- 2.1 Financial Report for October 2024

- 3.1 Statistics
 - 3.1.1 123 Membership renewals, 23 new card holders, Total items lent to other libraries 1309, Total items borrowed from other libraries 2028
 - 3.1.2 Number of items circulated 5201. Circulation up 3% from October 2023
 - 3.1.3 Overall circulation up 1.8% from last year
 - 3.1.4 Social media: Facebook up 3, Instagram up 2

3.1.5 On average patrons have saved 4360.68 to date this year which is up \$208.04 from last year.

3.2 Operations

- 3.2.1 Several staff opted to take vacations during the month of October
- 3.2.2 Several staff who run programs have complained about the lack of storage space available in the library for items they need for their programs
- 3.2.3 We are putting together a fundraiser with a local business (Leen's Greens) for the holiday season. There will be a couple of workshops to produce some holiday decor, costing \$50 per person with \$15 per person going to the library
- 3.2.4 The Canada Summer Jobs grant was paid out in October.

3.3 Programming

- 3.3.1 We had high attendance for programs this month, likely due to a 5 week month and our special event
- 3.3.2 Our collaboration with the Moose Hall on the Family Halloween Party had 180 attendees
- 3.3.3 Attendance is picking up for the new programs we started last month
- 3.3.4 Outreach maintains consistent use
- 3.3.5 A new staff member was trained to run outreach for vacation coverage this month
